EX-PARTE INQUIRY REPORT

Background:

This is with reference to the case registered on 09/04/2025, under Financial misconduct, with allegations of Financial Misappropriation & Absconding against Mr./Ms./Mrs. **Vishal Mishra**, bearing the Emp. ID - SF0092253. The employee has not taken due care while discharging his/her duties, and the charges mentioned in: Initial SCN dated 10/04/2025 and Detailed Show Cause Notice (DSCN) issued post Fraud Investigation on 30/04/2025. (Copy of the SCN letter/s is attached as **Annexure - I**)

A Notice of Inquiry was issued to the alleged employee, vide letter dated 05/05/2025, informing that Mr./Ms./Mrs. Vishal Mishra, to present him/her self for the Internal Inquiry proceedings which was addressed by the Disciplinary Inquiry committee/Officer, scheduled on 06/05/2025. (Copy of the Notice of Inquiry letter is attached as **Annexure -II**)

On the 06/05/2025 (Inquiry date), I/we along with other committee members were present; however, the alleged employee was not present for the Inquiry.

Submissions from the Committee:

The Inquiry Committee/Officers presented the version of the management along with the documents/evidence submitted, as stated below:

The Inquiry Committee/Officer submitted that, through the mail dated 08/04/2025 from Mr./Ms./Mrs. Santosh kumar SF0071836 Cluster Manager, it was informed to the management that Mr./Ms./Mrs. Vishal Mishra SF0092253 Credit Assistant allegedly committed misconduct under Financial Misappropriation & Absconding on 07/01/2025. The complaint mail is attached as **Annexure -III**.

Also, it has been presented that the Show Cause Notice dated 10/04/2025 was issued to Alleged Employee Vishal Mishra against the alleged charges. After that, considering that Mr./Ms./Mrs. Vishal Mishra's presence in the branch would potentially lead to influencing the evidence specific to the alleged charges, a suspension letter was issued to him on 09/04/2025. A copy of the same is attached as **Annexure -IV**.

Employee has not responded to the Show Cause Notice issued.

And then presented the alleged employee's reply to the Detailed Show Cause Notice via letter dated 02/05/2025, which is attached as **Annexure - V**.

Thereafter, the Committee has validated the available records (reports) and factual information provided by the management in support of the charges made.

Thereafter, an opportunity was given to Mr./Ms./Mrs. Vishal Mishra to verify/examine the witness/evidence in their defense.

Submissions from Alleged Employee:

The alleged employee did not attend the inquiry proceedings, despite prior communication. The Inquiry was closed after confirming with the attending parties that they had full opportunity to present witnesses and evidence, and that nothing else was to be presented.

Observation: Mr. Vishal Mishra Involved in Financial Misappropriation & Absconding from branch. An allegation of "Financial Misappropriation and Absconding from duties from 28th March- 2025" has been made against him. It has been found that "he has Collected 01 Pre-close of total amount Rs.42,000/-on 07th January- 2025 from the Borrower -Navita Maurya for Loan No- 358042339, which were not Posted in FIMO nor submitted at the branch. During the investigation, it was observed that LO Vishal Mishra/SF0092253 embezzled in the EMI amount, misappropriation of multiple borrowers from multiple centres. Total Fraud amount is Rs. -149443/- Recovered amount is Rs. -31390/-only. The alleged employee involved in the investigation of financial embezzlement has not participated in any of the proceedings. The employee has failed to respond to calls and messages sent to the registered number. Further, he has absconded from the branch. The ZDAC Member concluded from the absence of the employee that the employee was indeed involved in financial embezzlement and recommended closing the case at level 1-Closed with Termination.

Inquiry Findings:

On hearing both the sides, statements recorded above and reviewing the supporting evidence submitted by both the parties, it is thereby concluded that there is adequate evidence to support the charges, and Mr./Ms./Mrs. Vishal Mishra has violated Company's rules and is guilty of the charges mentioned under the said category in the Show Cause Notice dated 10/04/2025 and the Detailed Show Cause Notice (DSCN) issued post Fraud Investigation dated 30/04/2025.
