**Describe how the incident has been exposed/identified:**

After CSS Complain I visited Chandikhol-2 (OR3106) by Executive Abhijit Rout/SF0075084 visited Center 546400 and observed that Lo Biranchi Narayan Mishra/SF0082345 had collected EMI from borrower Kanakalata Padhi **Rs.3200/-** but that amount not inputted in FIMO. The borrower provided Phone-pe Screenshot and Loan Card as evidence. As per the above collection misappropriation, the complaint was lodged on 4<sup>th</sup> Jul 2025, vide complaint Number **FN25-26-01237**.

Now LO Biranchi Narayan Mishra/SF0082345 is Terminate as per HR records.

Post completion of the investigation, we identified **Rs. 3200/-** amount of cash misappropriation on 1 no's of borrowers against LO Biranchi Narayan Mishra/SF0082345.

**Brief Details of the incident:**

**Investigation Approach:**

The Audit team visited some Borrowers, those handled by Biranchi Narayan Mishra, to check the availability of the borrower, and the amount collected was not accounted for.

**Modus Operandi:**

Loan Officer Biranchi Narayan Mishra employee ID SF0082345, made a cash misappropriation with an amount of **Rs-3200/-** for 1 borrower.

- The internal audit team investigated by visited all 11 borrowers handed by LO.
- Post Verification, it was observed that a total of 11 no's Borrowers visited, out of that 6nos of borrowers were present & 5 no's borrowers were "Not available at home" at the time of verification. Observed fraud for 1nos borrowers of **Rs 3200/-**. So Net Fraud Amount Rs-**3200/-**.
