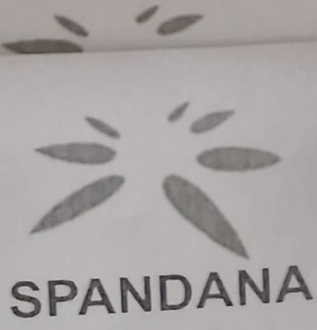

5. The information stated in the **Annexure** is true and correct to the best of my knowledge.

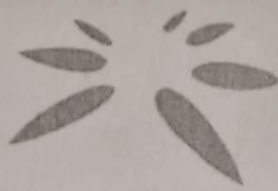
