**Describe how the incident has been exposed/identified:**

Associate Vice President Nagaraju Vedula/SF0081143 identified Collection & loan amount misappropriation in the branch for which the credit assistant Sajja Jaswanth/ SF0084662 collected EMI collection & loan amount from borrowers and did not hand over the collected amount at the branch. The complaint was raised by the AVP on 05<sup>th</sup> Nov 2025, and the complaint was registered on 11<sup>th</sup> Nov 2025 with vide complaint number FN25-26-02860.

**Brief Details of the incident:**

**Investigation Approach:**

The audit team visited the branch to further verify the complaint. The collection & loan amount misappropriation was identified, which was done by the Sajja Jaswanth/ SF0084662, to check that the collection & loan amount was not accounted for.

**Modus Operandi:**

The credit assistant Sajja Jaswanth/ SF0084662, embezzled the collection & loan amounts from borrowers during the collection from the field.

The internal audit team investigated the branch and visited the field, and verified 34 borrowers of the branch. The amounts of embezzled fraud collection are given below.
